3/14/2024	Net Energy Metering 1 and 2 Program	Account Services	The PCE Community Advisory Committee supports the staff recommendation regarding changes to the NEM annual cash out policy, and asks PCE to encourage the excessive solar generators to fully electrify their facilities, add battery storage, and/or explore the potential for microgrids.	Team is evaluating how to best target a message to the customers who would be good candidates for additional electrification messages. Planning to start with customers that still receive a physical check from us during their trueup; we will modify the communications they receive during the true-up process.
5/9/2024	Customer Call Center	Account Services	The CAC supports the plan to transition to an in-house contact center solution to enhance overall customer experience and support PCE's decarbonization program goals. The CAC recommends exploring the inclusion of some evening and weekend hours.	The Customer Success Advisor (CSA) team is starting with a group of three that will initially cover regular business hours of 9-5 M-F (Excluding Holidays), with one staff member working a slightly flexed schedule to 5:30 to be able to assist customers who call at the end of the day. We will be doing analysis during Q1 and Q2 to better understand the call flow and workload and will revisit whether adding additional staff to cover extended weeknight and/or weekend hours would be beneficial.

The CAC recommends that staff proactively communicate this decision to our customers. The CAC supports PCE's plan to write a letter arguing against the extension of Diablo Canyon after 2030. The CAC recommends the addition of the following point to the letter: if Diablo Canyon is extended after 2030, we don't want our customers to pay for it. And to post the letter publicly on the PCE website.	Sonoma Clean Power (a fellow CCA) drafted an initial letter regarding the future of Diablo Canyon that includes revisions from CalCCA. PCE and other CCAs since received feedback from the Governors office that a letter may be better received at a future time when Diablo Canyon is under consideration.
